The James Frizelle Charitable Foundation (JFCF) was established in 2019 to support those who have contributed to our great country but may have unfortunately through no fault of their own, fallen on hard times and can no longer speak for themselves. Inevitably they may not have Government support and are not considered popular or newsworthy charitable projects. They remain the “forgotten” in our society. We wish to assist them to get their life back on track and restore their dignity. We can do this by working with other eligible charities who have the necessary expertise and human resources but need our financial support.

The James Frizelle Charitable Foundation R1 & R2 Grants program can only provide funds to not-for-profit organisations Endorsed by the Australian Tax Office as Item 1 Deductible Gift Recipients (DGRs). To confirm DGR 1 status, enter the organisation’s ABN at this link: <http://www.abr.business.gov.au> Note: No Auspicing is permitted.

There is no upper threshold for JFCF contribution under these programs and applicants should apply for the amount required to implement their project. As an indication, previous grants range between \$2,000.00 - \$100,000.00 p/a (unless previously agreed by JFCF) for a range of grassroots, community-led initiatives that directly and clearly benefit our local communities located within the Qld/NSW Local Government Areas (LGA's) of the Gold Coast, outback Qld (west of Toowoomba Range) Tweed Heads, Byron Bay & Lismore, which align with one or more of the following priority areas:- Community Health, Disadvantaged, Domestic Violence, Homelessness, Housing & Accommodation and Mental Health. Locations outside our local LGA's **may** be considered for stand-alone projects within the above priority areas, providing they align with our mission and excess funding is available. Where more than one program may be applicable, please select that which has most relevance. If you are unsure which, please contact us prior to completion of your application.

We **will** consider grants both within or outside our LGA's for Natural Disasters where they align with our mission.

We will do our best to support the amount required, however JFCF may offer successful applications less money than requested and multi-year Grants may or may not be awarded, so we recommend applicants consider how this may impact their project when applying.

A broad range of charitable projects will be considered under these programs, including:

- Delivering, or providing activities, events, programs and services;
- The provision of health care services to those not necessarily cared for in the private or public system, particularly the special needs of senior citizens, including the promotion of a healthy lifestyle, eating well and assistance in recovery from illness.
- Community projects including resource development and/or the purchase of equipment/materials, assets and infrastructure.
- Providing support for those in the community, in particular the aged and infirm; those facing physical or mental disability who are from low income backgrounds and lacking the financial resources to seek help from other sources; improving community health and social wellbeing; projects that are inclusive of those with a disability providing services for others; the provision of food services to disadvantaged families; the provision of assistance dogs, equine and animal programs that provide independence, self-esteem, improved health and relationships to individuals and families.
- Enabling people to develop skills, knowledge and confidence to lead and contribute to the prosperity of their community.
- Building a sustainable volunteer base and/or supporting the wellbeing of volunteers;
- Reducing the divide on access/connectivity/knowledge to digital technology;
- Assistance to those (victims and witnesses which are often children) experiencing domestic and family violence including those suffering psychological and emotional abuse and any other form of Elder abuse or to raise awareness in the community that domestic violence in any form is not acceptable.

What Can Be Funded continued....

- Support for those, particularly the elderly and frail without regular accommodation and facilities to help maintain their dignity by providing emotional support and counselling; temporary accommodation; health services; financial counselling, laundry services; meals; shower facilities and any other service that assists to improve their quality of life.



JFCF R1 & R2 Grants Program are not available to fund:

- Overseas aid of any sort;
- Costs or areas of responsibility of the Federal, State and Local Governments eg. schools, universities, hospitals etc. or any research therein;
- Retrospective/Deficit funding;
- Medical Research;
- Drug and alcohol rehabilitation and support;
- Projects benefiting private individuals; sole traders, private or commercial businesses, government entities; political lobbying; research;
- Part of a general fundraising appeal;
- Debt payment;
- Sporting related events;
- Travel and accommodation—unless they directly relate to the provision of services;
- The promotion of a religion, political party or business;
- Programs that exclude people based on their race, sex, gender, religious affiliation or for other reasons, unless justified (e.g. it is required to create a safe space);



An organisation will be considered ineligible if:

- Application is submitted by individuals, sole traders, private or commercial businesses (as per the submitted ABN);
- Application is submitted by a delivery organisation that is not a legal entity (does not have DGR1 status);
- Application is incomplete eg:- financial documentation is not supplied; unbalanced budget; quotation not supplied. NOTE: Due to the volume of applications received, applications are assessed based on the documentation received at the time of application. JFCF is unlikely to follow up missing documentation after applications have been submitted.
- Final report/s from previous JFCF grants awarded are overdue or unsatisfactory;
